**NOTIFICATION**

No.439-Home(Cons.) Dated, Kolkata, the 16<sup>th</sup> day of December, 2011 ---In exercise of the power conferred by clause (3) of article 166 of the Constitution of India, the Governor is pleased hereby to make the following amendments in the West Bengal Rules of Business (hereinafter referred to as the said rules):-

**Amendments**

In the First Schedule to the said rules, under the heading 'Allocation of business among departments,-

(1) under the sub-heading 'XLI. Backward Classes Welfare Department', in Part I,-

(a) for item 21 and the entries relating thereto, substitute the following item and entries:-

"21. Organisation of cultural activities of various ethnic groups, particularly of Bhawaiya Song Competition, Tribal One-Act Drama Competition and Hul Utsov, Tea Tribal Festival etc. viz. Jhumur, Gambhira, Baul, Bhatiyali, Kabi-Gaan, Puppetry, Chhau, Sarigan and Bachhari Baich (traditional boat race), Woodcrafts, Kantha Silpa, Observance of the movement of 1873 for dignity and equality before law";

(b) for item 34 and the entries relating thereto, substitute the following item and entries :-

"34. Development and Maintenance of cultural cum educational schemes like Uttarbanga Lokasanskriti Parishad, Paschimbanga Santhali Academy and Panchanan Barma Sangrahashala O Gabeshana Kendra, registered under the West Bengal Societies Registration Act. 1961(West Ben. Act. XXVI of 1961) and Banga Lok-Shilpa-O-Sanskriti Kendra concentrated to the eastern part of South Bengal."
