The meal charges for Pre-Matric Scheduled Caste hostellers were last revised to Rs. 1000/- (Rupees one thousand) only per month with effect from 01.04.2018 as per order no. 377-BCW/SC/SSM-14/2017 dated: 02.02.2018 of this department.


2. The prices of various essential food items have gone up considerably during the last few years and the matter of enhancement of the meal charges of the hostellers for Scheduled Caste students was under the active consideration of the State Government.

3. Now, after careful consideration of the matter, the Governor has been pleased to enhance such charges from Rs. 1000/- (Rupees one thousand) to Rs. 1,800/- (Rupees one thousand and eight hundred) only with effect from 01.01.2024 as shown in item (i) and (ii) until further order:

- (i) Pre-Matric Hostel charges for Scheduled Caste students (school attached hostel)
- (ii) Meal charges for Scheduled Caste students residing at Ashram Hostels run by this department.

4. All Concerned are being informed.

5. This order is issued with the concurrence of Finance Department, Govt. of West Bengal, vide their (Gr. N) U.O. No. 3979 Dated: 21.12.2023 and this has the approval of the Secretary of this department.
