No. 297(Sanction)/P/SC dated 08.03.2018 & G.O no:73(Sanction)/P/SC/6S-14/2016 dated 06.06.2018 I am directed to say that the Governor is pleased to make an allotment of Rs.1,90,60,088/- (Rupees One crore ninety lakh sixty thousand eighty eight) only being placed at the disposal of the District Magistrate, Jalpaiguri for the purpose of meeting a part of the cost of construction of 51 Anganwadi Centers of ICDS at SC populated areas of the district of Jalpaiguri as 3rd & final installment.

The Governor is also pleased to allow the drawal of the aforesaid amount of Rs.1,90,60,088/-(Rupees One crore ninety lakh sixty thousand eighty eight) only, being placed at the disposal of the District Magistrate, Jalpaiguri who is hereby authorized to execute the Scheme. It should be ensured that no NGO run ICDS Centers can be constructed with this fund and the supervision may be made from the engineering cell of PO cum DWO, BCW, Jalpaiguri. In addition, the land where the proposed AWCs would be constructed must be a Govt. land. The allotted amount is to be utilized in respect of the A.W. Centres as embodied in the list to memo no. 2910/PO-DWJ/BCW dated 26.02.2018 of PO cum DWO, BCW, Jalpaiguri.

The District Magistrate, Jalpaiguri, will furnish the Utilization Certificate to this Department in due course.

The above charge of Rs.1,90,60,088/- (Rupees One crore ninety lakh sixty thousand eighty eight) only on this account will be debited to the head of account "4225-Capital Outlay on Welfare of Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities-01-Welfare of Scheduled Castes-277-Education-State Dev. Schemes-012-Infrastructure Development Programme including construction of ICDS Centres [SC]-V-53-Major Works/Land and Buildings" under Demand No. 07 and Department code-SC (Code: "07-4225-01-277-State Dev. Schemes-012-V-53") from the Budget of the current financial year, 2022-23.

I am also directed to add that allotment of funds is no authority to incur expenditure without previous sanction of Government where such sanction is necessary under the standing rules and orders.
