The Governor has further been pleased to sanction and make allotment of the said amount of Rs.21,00,000/-(Rupees twenty one lakh) only to the Managing Director, West Bengal Scheduled Castes and Scheduled Tribes Development & Finance Corporation, who will draw the entire amount of Rs.21,00,000/-(Rupees twenty one lakh) only by transfer credit to the Deposit Account of the Corporation under the head, "8449-Other Deposit-00-120-001-Deposit to Government Companies and Corporation" maintained in Kolkata Pay & Accounts Office by submission of necessary bill for the said purpose and shall then be transferred to the Bank Account of the West Bengal Scheduled Castes and Scheduled Tribes Development & Finance Corporation and shall be kept in the Bank Account of the said Corporation for subsequent utilisation.

The charge will be debitible to the head, "2225-Welfare of Scheduled Castes, Scheduled Tribes and Other Backward Classes-02-Welfare of Scheduled Tribes-796-Tribal Areas Sub-Plan-SP-STATE PLAN (ANNUAL PLAN & ELEVENTH PLAN)-043-Infrastructure Development Programme (SC)-50-Other Charges-V" (Code:2225-02-796-SP-043-50-V) under Demand No.'7', Department Code-SC out of the budget provision for the financial year 2009-10.
